

CERTIFICATE OF INCORPORATION OF HABITAT FOR HUMANITY OF SULLIVAN COUNTY, INC.

Under Section 402 of the Not-For-Profit Corporation Law,

THE UNDERSIGNED, acting as Incorporators of a Corporation under the New York Not-For-Profit Corporation Law hereby adopt this Certificate of Incorporation for a Type "A" Corporation pursuant to Section 201. This corporation is organized as a tax-exempt organization under Section 501(c)(3) of the Internal Revenue Code.

ARTICLE I

The name of the Corporation is HABITAT FOR HUMANITY OF SULLIVAN COUNTY, INC.

ARTICLE II

This Corporation is not organized for pecuniary profit, nor financial gain, and no part of its assets, income, or profit shall be distributable to, nor inure to the benefits of its members, directors and officers, except to the extent permitted under the Not-For-Profit Corporation Law. The Corporation shall be a Type "A" corporation pursuant to Section 201 of the New York State Not For Profit Corporation Law.

ARTICLE III

The county within the State of New York in which the activities of the Corporation are principally to be conducted, is Sullivan County. The office of the corporation is within Sullivan County.

ARTICLE IV

The purposes for which the Corporation is organized are as follows:

(a) To witness to and implement the gospel of Jesus Christ in New York and throughout the United States and the world by working with economically disadvantaged people to help them create a better human habitat in which to live and work.

(b) To cooperate with other charitable organizations, through grants and otherwise, which are working to develop a better habitat for economically disadvantaged people.

(c) To communicate the gospel of Jesus Christ by means of the spoken and written word.

(d) To receive, maintain, and accept as assets of the Corporation, any property, whether real, personal, or mixed by way of gift, bequest, devise, or purchase from any person, firm, trust, or corporation, to be held, administered, and disposed of exclusively for charitable, religious, educational, and scientific purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, and in accordance with and pursuant to the provisions of this Certificate of Incorporation; but no gift, bequest, devise, or purchase of any such property shall be received or made and accepted if it is

conditioned or limited in such manner as shall require the disposition of income or principal to any organization other than a "charitable organization" or for any purposes other than "charitable purposes" which would jeopardize the status of the corporation as an entity exempt from federal income tax pursuant to the relevant provisions of the Internal Revenue Code of 1986, as amended.

(e) To exclusively promote and carry on any other religious, charitable, or educational purposes and activities for which corporations may be organized and operated under the relevant provisions of the Internal Revenue Code, as amended, and under the

Not-For-Profit Corporation Law of the State of New York.

(f) Anything to the contrary notwithstanding in this Certificate of Incorporation, the Corporation shall not carry on or otherwise engage in any activities not permitted to be carried on or engaged in by (1) a Corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or any corresponding section of any future tax code; (2) a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1986, as amended, or any corresponding section of any future tax code; or (3) a corporation organized and existing under the Not-For-Profit Corporation Law of the State of New York.

(g) Except as hereinafter provided, the Corporation shall have all powers necessary or convenient to carry out its purposes, including the powers now or hereafter enumerated in the Not-For-Profit Corporation Law of the State of New York.

ARTICLE V

The powers and activities of the Corporation shall be limited as follows:

(a) No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to any of its members, trustees, directors, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this Certificate of Incorporation. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in any political campaign on behalf of or in opposition to any candidate for public office.

I received a copy of the draft Certificat of Incorporation of HFH of Sullivan County, Inc. Thank you for providing Habitat Northeast this document for review. Since you have followed so closely the sample articles of in the <u>Affiliate Operations Manual I</u> have only a couple of comments:

In Article IV:

- (a) We request that you add the phrase "witness to and" between "To and implement the gospel of Jesus Christ"... The language of the purposes was approved by the Internal Revenue Service in granting Habitat for Humanity International exemption as a 501(c)(3) organization and all affiliates that will come under the umbrella exemption must write purposes that mirror this language exactly.
- To prevent any potential misunderstandings about the language, it would be helpful to reverse (c) and (d) to follow the HFHI purposes.
- Your current (d) is missing the words "spoken and" before "written word".

Article VIII:

Habitat for Humanity International recommends that its affiliates not be membership organizations. The language below is quoted from correspondence from Regina Hopkins, Staff Counsel for Habitat for Humanity International, to another Habitat Northeast prospective affiliate in regard to the issue of membership:

"The existence of voting members creates complexities related to establishing who is a member, maintaining accurate membership lists, complying with requirements related to notice of meetings and issues concerning quorum requirements. Also, the existence of voting members creates the possibility of a small group influencing or taking over the organization. The existence of either voting or nonvoting members may create additional derivative liability exposure for directors and officers... If the affiliate will have members, the By-Laws should contain detailed provisions regarding qualifications and admission, voting rights or limitations thereon, meetings, notice of meetings, quorum requirements, termination of inactive members, and maintenance of membership records."

Affiliates that have decided to have members generally limit the membership to a self perpetuating board of directors. Enclosed find two exerpts from the Affiliate Operations Manual that expand upon the reasons behind these recommendations.
